RE: Noise Variance Permit Applications

On Thursday, July 30th, I, DEO Jason Vogel, reviewed the Noise Variance Permit Application completed by Patrick Sullivan, located at the address of 3145 East River Dr. Patrick is requesting a noise variance on August 28<sup>th</sup> and 29<sup>th</sup>, for a wedding rehearsal and wedding reception in his backyard between the hours of 4:30pm to 11:00pm. The Wedding Rehearsal on Friday the 28th will have approx. 70 people in attendance and the Wedding Reception on the 29<sup>th</sup> has approx. 150 people invited. Patrick is applying for being allowed to play amplified music in his backyard for his daughter's wedding during these times. Patrick has provided his contact information and is listed as the contact person if there is a police issue.

I was able to speak with Patrick via a telephone call. Patrick stated he will keep his cell phone on his person during these times and agreed if there is an issue police could contact him. Patrick stated they will have a band on Friday and a DJ on Saturday. Patrick agreed to point the speakers east towards the East River as there are no neighbors directly behind him. Patrick stated neighbors have either been notified about this wedding or are even invited to come so there should be no complaints about parking or noise. I explained to Patrick this application will be address at the next village board meeting on August 4<sup>th</sup>, 2020. Patrick stated he has a business obligation at that time but will attempt to have his daughter present online to address any questions the board members may have. If Patrick's daughter is unable to attend Patrick states he is available via a telephone call in the following days at the phone number he provided. At this time I am requesting an approval for this Noise Variance Permit Application.
