RESOLUTION REGARDING THE SPENDING OF THE EXCESS GREEN BAY/BROWN COUNTY PROFESSIONAL FOOTBALL STADIUM DISTRICT SALES TAX

WHEREAS, On March 31, 2015 the Green Bay/Brown County Professional Football Stadium District Board completed the certifications necessary to end the football stadium district sales tax on September 30, 2015; and

WHEREAS, 2015 Wisconsin Act 114 provided a mechanism for football stadium district sales taxes collected or imposed between April 1, 2015 and September 30, 2015 to be paid back to Brown County and municipalities within Brown County; and

WHEREAS, On December 31, 2015, the Village of Allouez received \$704,677.09; and

WHEREAS, On September 30, 2016, the Village of Allouez received an additional \$21,307.85 from audit that took place after the initial distribution resulting in additional payments collected between September 16, 2015 and September 15, 2016; and

WHEREAS, On December 6, 2016, the Village of Allouez adopted Resolution 2016-23 allocating \$500,000 to be used to offset additional borrowing for 2017 street reconstruction projects as identified during the 2017 budget preparation, \$92,000 be used for a controlled pedestrian crossing on the south end of Riverside Drive, allocate \$100,000 for a controlled pedestrian crossing at the north end of Riverside Drive (pending approval and with an expiration date of July 31, 2017) and \$25,985 for wayfinding signs within the village limits; and

WHEREAS, On December 20, 2016, the Village of Allouez adopted Resolution 2016-24 to enter into a Memorandum of Understanding with the Village of Ashwaubenon, Village of Howard, Town of Lawrence, County of Brown and NEWEYE, through Brown County Innovations Inc. to provide Public, Education, and Government (P.E.G) television programming at a cost not to exceed \$8,000, per the agreement on December 6, 2016; and

WHEREAS, On August 1, 2017, the Village of Allouez adopted Resolution 2017-28 amending the allocation of the \$100,000 for a controlled pedestrian crossing at the north end of Riverside Drive pending approval by the State DOT and with an expiration date of October 31, 2017; and

WHEREAS, The Village of Allouez received an additional \$20,292.28 from audit that took place between September 16, 2016 and September 15, 2017; and

WHEREAS, On November 21, 2017, the Village of Allouez adopted Resolution 2017-34 allocating \$14,250 for budget relief in the 2018 Village Budget; and

WHEREAS, The Village of Allouez received an additional \$12,267.43 from audit that took place between September 16, 2017 and August 31, 2018; and

WHEREAS, On November 20, 2018, the Village of Allouez adopted Resolution 2018-14 allocating \$120,000 for budget relief in the 2019 Village Budget; and

WHEREAS, The Village of Allouez received an additional \$4,485.98 from audit that took place between September 1, 2018 and August 31, 2019; and

WHEREAS, On November 19, 2019, the Village of Allouez adopted Resolution 2019-25 allocating \$175,000 for budget relief in the 2020 Village Budget; and

WHEREAS, The Village of Allouez received an additional \$976.51 from audit that took place between September 1, 2019 and August 31, 2020; and

WHEREAS, The Village of Allouez may use the funds for the purpose of providing property tax relief, tax levy supported debt relief, or economic development.

NOW, THEREFORE, BE IT RESOLVED, that the Village Board of the Village of Allouez, hereby approves allocating \$21,340 for budget relief in the 2021 Village Budget.
