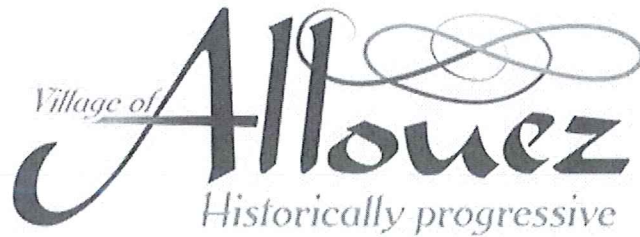

LE BRUN ROAD PROJECT

The Le Brun agreement between De Pere and Allouez is proposed to be revised as follows:

1. The east section of Le Brun, east of East River Drive, will be segregated into a separate agreement so that this can be approved. This is per the last Public Works Committee meeting.
2. The west section of Le Brun, west of East River Drive, is proposed to be revised as follows—subject to Village Board approval on June 4th.
 - a. Delete the proposed sidewalk between McCastlen and Libal Street. De Pere has provided sidewalk already on a portion of this street, and does not want to participate in further sidewalk in this section. The Public Works Committee felt that this could be a cost to be handled by Allouez should this proceed in the future.
 - b. Consider a revision to the draft agreement to detach the De Pere section between East River Drive and McCastlen, and annex this section to Allouez. This has been discussed with De Pere and De Pere has asked that a formal request be submitted to De Pere, subject to Allouez agreeing to not construct a street in this section.
3. Proposed Village Board Action:
 - a. Delete De Pere participation in an Allouez sidewalk west of McCastlen should this be constructed in the future.
 - b. Submit a request to the city of De Pere to detach the section of Le Brun from East River Drive to McCastlen and annex this section to the village of Allouez. A draft letter is attached.
