Titletown Tobacco Members Association has applied for a Temporary Class "B" Retailers License to sell fermented malt beverages and wine in a fenced in area of the parking lot (wristbands will be issued) at 516 Greene Avenue on September 7, 2013 from 3:00 – 7:00 pm. Per Mike Gehm, landlord approval was given to use the parking lot and tenants were notified. They plan to have food catered.

Intoxicating Liquors FAQ 25

Who can obtain temporary (picnic) beer and wine licenses?

Picnic licenses can only be issued to "bona fide" clubs, fair associations or agricultural societies, churches, lodges or societies that have been in existence for at least six months, and to veterans' organizations. Wis. Stat. secs. 125.26(6) and 125.51(10). The dictionary defines "bona fide" as authentic, genuine, done or made in good faith, without deception or fraud. "Club" is defined as a group of people organized for a common purpose, especially a group that meets regularly. The definition of "club" in sec. 125.02(4) appears to be inapplicable to picnic licenses.

An individual, partnership, or business corporation is not eligible for a picnic license.

POLICY NO. 23

FILING PERIOD FOR CLASS B "PICNIC" BEER/WINE LICENSES AND ISSUANCE OF LICENSE BY VILLAGE CLERK-TREASURER

The Village Board established a filing period of 3 days for Class B "picnic" beer/wine licenses. Authority was given to the Clerk-Treasurer to issue reoccurring Class "B" picnic/beer licenses. New applications are to be brought to the Village Board for approval.
