Genrich / Green moved to approve extension of closing date for property at 1649 & 1677 S. Webster Avenue from December 31, 2017 to February 28, 2018 as requested by the buyer in order to allow them the opportunity to obtain alternate means for financing the project. Motion carried.

LISTING CONTRACT FOR PARCELS AL-44, AL-44-1 AND AL-45

Dart / Harris moved to extend listing contract with James Wheeler for Parcels AL-44, AL-44-1 and AL-45 from December 30, 2017 to June 30, 2018. Motion carried.

<u>SERVICES FEE PROPOSAL FOR CONCEPTUAL STREET VIEW DESIGN OF WEBSTER AVENUE AND ST. JOSEPH STREET</u>

Green / Genrich moved to approve the Services Fee Proposal (from Somerville for \$10,000).

Discussion:

- Is the 10% markup for document submittal/approval fees standard
- This is a guide which provides us with ideas, nothing that must be done

Harris / Green moved to open the meeting for public comment. Motion carried.

Jim Orourke, 2339 Oakwood Avenue

- Pay Somerville whatever it costs to include the arboretum trail going down to Riverside Drive and also have them look at doing a study along Riverside Drive
- Fund Phase III to complete the Corridor Study

Dart / Genrich moved to return to regular order of business. Motion carried.

Upon the vote, the motion carried to approve the services fee proposal as submitted.

APPROVAL OF CSM FOR PROPERTY LOCATED ON THE SOUTHWEST CORNER OF DU CHARME LANE AND MIRAMAR DRIVE

Genrich / Green moved to approve the CSM for John & Kathleen Schumacher subject to contingencies submitted by Brown County being met. Motion carried.

DPW JOB DESCRIPTION

Lange

- With the pending retirement of Berndt, the Director of Public Works job description was reviewed. Changes include:
 - Consolidation of some of the duties and responsibilities and lists them in a more prioritized fashion.
 - Minimum years of supervisory work experience under Position Qualifications was reduced from 10 years to 5-7.

Discussion:

- Questioned the wording "in responsible charge as a Registered Professional Engineer" (Berndt

 that is normally how it is worded)
- Position qualifications. Reducing years of supervisory experience required would open it up to more candidates to choose from. (Berndt with a higher level of supervisory work experience they tend to have more experience and leadership skills to continue programs we face as a community reconstructing streets, utilities and other things we have to do.
- Is a registered professional engineer in Wisconsin necessary or could we list as preferred so we aren't limiting ourselves? (Berndt if they aren't a PE we will be contracting out for engineering work we currently do ourselves and are able to submit directly to the state. A PE also has a different level of authority.)
- Under Supervision/Decision Making, should specific number of employees supervised be listed? Number could change in the future and would require a job description update. List as currently 18 employees to give a point of reference for the applicant?

Harris / Dart moved to approve the Director of Public Works job description with the slight modifications discussed. Motion carried.

AMENDING SECTION 151-10 BEEKEEPING (from 12/05/17)

Discussion:

- Intent was to move forward to allow on private property
- Don't allow hives on the lot line. Bees come in and out of the hive someone on the next lot could have a bee allergy and it isn't fair to neighboring properties.
- Staff to look into how other communities specify where hives can be located in a yard
- Should the date in section B6 on page 2 be modified from June 30th
- Bring back an amended ordinance for consideration

VILLAGE PRESIDENT SALARY

Harris

- Due to the time and effort involved by the Village President, a salary increase was discussed during the 2016 and 2017 budget workshops to be effective in April 2019.
- Survey was taken of other communities to determine average gap between trustee and president compensation (Allouez is currently 24% - others were anywhere from 29 and 112%).

December 19, 2017 (Village Board Meeting)

- Could potentially offset an increase in the president position salary by a decrease in the trustee positions salary. Dropping six trustee salaries by \$232/yr would leave \$1400 for an increase in the president salary, providing a gap of 53.8% in line with other municipalities.
- Requires an ordinance change
- Clerk to verify when an increase or decrease can go into effect and will bring back to the Board

- Amending Section 151-10, Beekeeping
- Village President Salary
