Stand by your pan:

Turn pot handles toward the back of the stove:

Use it to cover the pan if it catches on fire. This will put out the fire.

- ***February 10th:*** Deputy C. Walker responded to an address on the 600 block of W. Briar Ln. for a fraud report. The victim reported he believes someone stole his mail that included checks. The victim's bank reported money was added to the stolen checks. A statement was obtained and a report was completed for identity theft.
- ***February 13th:*** Deputy A. Wysocki responded to the CVS Pharmacy, located at the address of 2222 S. Webster Ave. for a report of Fraud. The complainant

reported approx. 1 month ago a known suspect came into the store and forged their own prescription for themselves. Deputy Wysocki was able to locate the suspect and perform an interview. The suspect admitting to being addicted to prescription pills and writing fake prescriptions. The suspect was taken into custody and transported to the Brown County Jail on charges of Forgery (5 counts), Possession of a Controlled Substance (5 counts), Theft, and Bail Jumping.

- February 14th: At approx. 3:50am, Deputy Brown and multiple deputies responded to an address on the 3800 block of S. Clay St. for a report of a burglary that had just occurred. The victim reported an unknown suspect had broken a window with a shovel and stole a wallet off the counter. A perimeter was set up around the area. A Green Bay PD K9 Unit was used on the track left by the suspect. The track was followed to Ledgeview St. where it was believed someone had picked up the suspect with a vehicle. A report was completed for Burglary, Theft, and Criminal Damage to Property. This report was forwarded to the Brown County Investigative Unit for follow up.*
- On February 23rd, Deputy Walters responded to an address on the 600 block of W. Briar Ln for a report of theft from a mailbox. The victim reported mail was stolen from his mailbox at the apartment complex and that one of the letters had checks inside. The reported checks were cashed on Jan. 25th. The victim reported no suspects at this time. Statement obtained and report completed by Deputy Walters. Report forwarded to the Investigation Unit.*
- In the month of February, Brown County Sheriff's Office deputies responded to or initiated approximately 552 police calls in the Village of Allouez. This included approximately 232 Traffic Stops, 26 traffic crashes, 17 disturbance calls, and 16 welfare checks.*

Item #1

On Feb 4th, at approx. 2:20am, a traffic stop was performed on Riverside Dr at Allouez Ave by Deputy G. Gleason. Deputy Gleason was working on a state funded OWI grant at this time. The operator of the vehicle was pulled over for a lane deviation. Signs of intoxication by the operator were observed. The operator of the vehicle performed a standard field sobriety test and failed. The operator was issued citations for Operating While Intoxicated (OWI) 1st, Open Intoxicate in Vehicle, Lane Deviation, Operating Motor Vehicle Left of Center, Reproduce Driver's License, and Operating Without a License.

Item #2

On Feb 5th, at approx. 3:00am, Deputy C. Brown and multiple Brown County Sheriff's Office deputies were dispatched to area of Libal St and Beaupre St for a vehicle that struck a utility pole. Wires from the pole were on the ground at this time. Upon police arrival the operator of the vehicle was found to be impaired. Libal St. was blocked off by the Village of Allouez Street Department. Wisconsin Public Service was dispatched to fix the wires. The operator of the vehicle was issued citations for OWI 1st, Driving too Fast for Conditions, and Failure to Keep Control of the Vehicle. The operator was eventually released to a responsible party.

Item #3

On Feb. 6th, Deputy J. Milkie was sent to the Bellin Psychiatric Center, located at 301 E. St. Joseph St., for a report of a suicidal female making threats about overdosing on pills/alcohol. Deputies responded and took a female into custody. The subject was transported to the Crisis Center for evaluation. An incident report was completed by Deputy Milkie.

Item #4

On Feb 7th, at approx. 9:00pm, Deputy Milkie and multiple Brown County deputies were dispatched to an address on the 3700 block of Libal St. for an out of control male. Deputies arrived and the male was showing signs of a medically significant behavior. Green Bay Rescue arrived and the male was transported to a local emergency room for

medical clearance. The subject was later transported to the Crisis Center for evaluation. Incident report completed by Deputy Milkie.

Item #5

On Feb 10th, at approx. 4:30pm, Deputy S. Thor was dispatched to Webster Ave Market, located at 1220 S Webster Ave., for a report of retail theft. The suspect was cooperative with the staff at this time. Deputy Thor arrived and identified the suspect. A record check was performed and it was learned the suspect had an active warrant with Oconto County. The suspect was taken into custody for this warrant. The suspect was also issued a municipal citation for Retail Theft.

Item #6

On Feb 12th, at approx. 12:30am, Deputy R. Wagner and multiple deputies were dispatched to an address on the 2300 block of W. Serenade Ln for disturbance. Deputies arrived and spoke with an adult female. Deputies learned the other male suspect had already left the residence before police arrival. The female reported her boyfriend and her had been arguing since their ride home from downtown. Statements obtained from both parties involved. Case referred to the District Attorney's Office for charges of DVO Disorderly Conduct on both parties.

Item #7

On Feb 15th, at approx. 3:00am, Deputy J. Baudry and multiple deputies were dispatched to the 600 block of Memory Ave for a report of a Male vs Male physical disturbance. One of the male suspects left the scene before police arrival. The area was searched but police were unable to locate the suspect at that time. Deputy Baudry obtained statements and completed an incident report. At approx. 7:00am, the suspect was observed getting picked up at the residence. Deputies were able to locate the vehicle the suspect was picked up in on STH 172. A traffic stop was performed in the parking lot at Oneida Casino. The male suspect was taken into custody and transported to the Brown County Jail on charges of Battery, Disorderly Conduct, Obstructing an Officer, and a Probation Violation. At approx. 7:50am DEO Vogel was dispatched to a nearby address on the 800 block of Brookridge Ct. for a report of criminal damage to property. The victim reported a backyard tree house had its door and windows damaged. DEO Vogel obtained photographs of the foot prints left in the snow next to the treehouse. The prints appeared to match the shoes the suspect was wearing when taken into custody. A charge of Criminal Damage to Property was added to the suspects list of charges.

Item #8

On Feb 22nd, at approx. 4:30pm, Deputy D. Fameree was dispatched to the Subway located at 3907 S. Webster Ave for a report of employee theft. Deputy Fameree obtained a statement from the manager. Deputy Fameree was able to speak with the suspect at the store. A municipal citation was issued and explained to the suspect for theft.

Item #9

On Feb 23rd, at approx. 3:30am, Deputy Brown performed a traffic stop on a vehicle on Webster Ave at Broadview Dr. DOT records showed the owner of the vehicle was revoked and on probation for OWI. Deputy Brown identified the operator as the owner of the vehicle. Deputy Brown observed a full case of beer in the back seat of the vehicle. One of the conditions for the suspect was that he was not to be in possession of any alcohol. Probation/Parole was contacted. Probation/Parole advised they would place a hold on the suspect at this time. Deputy Brown placed the operator into custody and transported him to the Brown County Jail on this hold. Deputy Brown also issued citations for Operating Motor Vehicle while Revoked and Operating Motor Vehicle Without Insurance.

Item #10

On Feb 24th, at approx. 10:30pm, Deputy Baudry and Deputy Gleason (who was working WI OWI Grant) were dispatched to S Webster Ave at STH 172 for a truck that had struck a merge sign. Deputies arrived and observed signs of intoxication by the operator. The operator performed standard field sobriety tests and failed. The operator was issued citations for OWI 1st and Driving Too Fast for Conditions. The operator was eventually released to a responsible party.
